### 1. Definitions

#### 1.1 **Definitions**

In this document:

**DGA** means Darwin Greyhound Association Incorporated.

**Code of Conduct** means this document as amended from time to time by the DGA.

**Committee** means the committee of the DGA under its constitution.

**DGA Business** means the business conducted by DGA on the Land.

Winnellie Park means Portion 2781 Hundred of Bagot from plan(s) S 82/284

**Greyhound** being Crown Lease In Perpetuity 01271.

## 2. Winnellie Park Greyhound Precinct Code of Conduct

### 2.1 **Public and Family Friendly**

It is the policy and intent of management of the Darwin Greyhound Association Incorporated (the DGA) to provide a family friendly venue where the public can enjoy greyhound racing and associated hospitality in a responsible and friendly atmosphere.

#### 2.2 Commitments under the Code of Conduct

The DGA are committed to:

- a) Operate the DGA business in accordance with the Liquor Act (NT), relating to the sale and consumption of alcohol.
- b) To operate the DGA business in accordance with all laws relating to Racing of Greyhounds in the Northern Territory or greyhounds Australasia rules.
- c) To operate the DGA business in accordance with all the laws of the Northern Territory including Racing and Betting Act and Associations Act NT.
- d) It is of paramount importance all member and patrons understand the Code of Conduct will be strictly enforced. The DGA obligation and rights of the licensee relating to the sale and of consumption of alcohol will be politely and firmly enforced. This includes:
  - (i) Person entering Winnellie Park Greyhound precinct agree to abide by the precinct's Code of Conduct.

- (ii) Where a person / persons acts irresponsibly or behaves in a disorderly manner and when asked to leave the precinct of Winnellie Park they will do so in an orderly manner.
- (iii) Failure to abide by the Code of Conduct may result in refusal of entry, fine, removal or exclusion from the precinct for a period as determined by the Committee.
- e) All patrons/ members/ persons entering or while at the Winnellie Park precinct will; at all times:
  - (i) Not use derogatory language, including on race, religion or gender or be disrespectful to others.
  - (ii) Not swear; or use foul or abusive language.
  - (iii) Not be intoxicated.
  - (iv) Not use violence or physical force against other patrons / members / persons.
  - (v) Not abuse or show disrespectful behaviour to any other person including but not limited to a Committee person of DGA, any DGA staff, volunteers or race day officials or stewards.
  - (vi) Shall not intentionally damage any property or assets belonging to the DGA or other patrons / members / person involved at the Winnellie Park Greyhound precinct.
- f) Winnellie Park Greyhound precinct is deemed to be a public place in accordance with Northern Territory legislation and it is expected all members and patrons will demonstrate public manners, respect and morality to all other all persons visiting the Winnellie Park Greyhound precinct.
